

The combined scourge of COVID-19 and protectionism has dealt a mighty blow to global trade and the economy, the likes of which have not been seen since the Great Depression in the 1930s.

As a global trading and financial hub, Singapore has been affected in unprecedented ways as traditional growth engines like aviation and tourism have slowed down to a trickle. The knock-on effect on other sectors and services has led to Singapore entering its worst recession since independence, affecting many jobs and lives.

COVID-19 continues to batter the world and shutter many businesses. Yet, others have taken the opportunity to radically transform their businesses as they pivot to the digital space and new sectors amid the pandemic.

Underpinning these radical changes are a slew of innovations that have hit the market in double quick time, making the task of optimising and protecting Intellectual Property (IP) even more urgent as companies race to survive and seize upon any competitive advantage, against a background of cost management and prudence.

As the Singapore government shifted into high gear to tackle the economic challenges, IPOS was also hard at work.

FROM FIRM FOUNDATIONS TO NEW FRONTIERS


Many of the initiatives we introduced in the last Financial Year (FY) had their roots in the work that IPOS has done over the past eight years.

IPOS has strengthened Singapore's IP regime through several legislative reviews and updates, including for registered designs, IP dispute resolution and copyright.

We have also evolved from being a strong Registry to becoming a key innovation agency in building Singapore's future economy. In 2016 – 2017, IPOS contributed to the work of the Committee on the Future Economy (CFE), and subsequently updated the IP Hub Master Plan to help Singapore achieve better economic outcomes in a future economy increasingly powered by intangible assets (IA).

As an innovation agency, IPOS has stepped up efforts to help enterprises and innovators use their IP for growth and build Singapore as a hub for IP commercialisation.

These cumulative efforts (see sidebar) positioned Singapore as an international hub for the flow of IA and IP and enabled us to support enterprises better in the pandemic.



TOP 10 INITIATIVES

- 2013: Launched the IP Hub Master Plan to develop Singapore as a Global IP Hub in Asia.
- 2014: Launched a S\$100 million Intellectual Property Financing Scheme to help local businesses use their granted patents as collateral for bank loans.
- 2014: IPOS was officially appointed as ASEAN's first International Searching Authority (ISA) /
 International Preliminary Examining Authority (IPEA) under the Patent Cooperation Treaty.
- 2017: Updated the IP Hub Master Plan, in light of the recommendations of the Committee on the Future Economy, to help Singapore achieve better outcomes in the future innovation economy.
- 2019: Enhanced the IP Mediation Promotion Scheme by increasing funding from \$\$5,500 to either \$\$10,000 or \$\$12,000 for each mediation case. The enhanced scheme allows parties to claim for mediation-related agent fees.
- 2019: Established a new registry for Geographical Indications applications from anywhere in the world.
- 2019: Launched IPOS Go, the first app globally that allows innovators to apply for trademarks viaa mobile device in less than 10 minutes.
- 2019: Introduced the first national-level Skills Framework for the IP sector, to raise overall
 competencies of IP professionals and guide career pathways in the IP sector.
- 2019: Launched IPOS International, bringing together more than 100 experts to help advise
 businesses in areas such as IP strategy and management and patent search and analysis.

2020: Partnered with SGX to help companies identify and communicate the value of IA information to stakeholders.

EXPEDITIOUS AND QUALITY IP AMIDST COVID

COVID-19 has put the spotlight on speed and digitalisation in IP registration and management, without compromise to quality.

In the last FY, we launched and enhanced the world's fastest patent application to grant programme which accelerates patent application grants to just six months.

From expediting grants for AI-related patent applications, expanding this to all technology fields, and then reaching beyond patents to accelerate registration for trademarks and registered designs, IPOS is continuously innovating to give enterprises a business edge, especially in the current perilous times, where time is of the essence and there is a flight to quality.

Just as businesses have had to pivot to the digital realm, IPOS brought the convenience of IP registration to a mobile app. Launched in August 2019, IPOS Go is the world's first mobile trademark registration app.

With the mobile app powered by AI technology, businesses can do a quick search for similar trademarks that are already registered. An enhanced feature to search similar business names, domain names and social media account names will be launched in the next few months. The app's renewal features will also eventually extend to patents and registered designs.

SCALING UP IP CAPABILITIES

IPOS has also been helping enterprises to scale up their manpower to leverage IP.

At IP Week 2019, we launched the world's first national-level framework to develop and train IP talent to support the demand for skilled IP manpower. In early 2020, IPOS and SGX also launched a pilot programme to help companies identify and communicate the value of IA information to stakeholders.

As IPOS continues to support enterprise growth through IP/IA education and management, we are glad that many companies have benefitted from our initiatives and some have even capitalised on new business opportunities using IP during the pandemic.

IP THROUGH SINGAPORE AND TO THE WORLD

As a hedge against protectionism, IPOS has been active on the international front, opening new avenues of bilateral cooperation to promote business as well as playing a role in the global IP system.

The ASEAN Patent Examination Cooperation (ASPEC) Acceleration for Industry 4.0 Infrastructure and Manufacturing (ASPEC AIM) is a major initiative with nine participating ASEAN IP Offices that prioritises patent applications in emerging technologies such as FinTech, cybersecurity and robotics.

We also launched the Patent Cooperation Treaty (PCT)-ASPEC which allows patent applicants to use PCT reports from an ASEAN International Searching Authority (ISA) / International Preliminary Examining Authority (IPEA)¹ to accelerate their patent applications in another ASEAN country.

Singapore agreed to work with China, Japan, Kazakhstan, Laos and Russia to expand IP cooperation in education and training, knowledge exchange and patent search and examination services.

We also marked a significant milestone in Singapore's history when IPOS' CE Daren Tang was elected Director General of the World Intellectual Property Organisation (WIPO). This is the first time a Singaporean will be helming a United Nations agency. The IP ecosystem has been greatly encouraged by this historic achievement.

In his acceptance speech, Daren shared his vision for a more inclusive, balanced and forward-looking IP ecosystem that will benefit all nations. IPOS shares this vision.

IPOS WELCOMES RENA LEE AS ITS NEW CHIEF EXECUTIVE



Mrs Rena Lee was appointed Chief Executive of IPOS on 1 August 2020. She succeeds Daren Tang, who left IPOS to take up the appointment of Director General of the World Intellectual Property Organisation (WIPO).

Rena began her career in the public service with the Ministry of Defence in 1992 and was called to the Singapore Bar in 1993. She later joined the Attorney-General's Chambers in 2008 and has specialised in the practice of international law.

Rena was most recently Minister-Counsellor at the Hague Diplomatic Office of Singapore. She is Singapore's Ambassador for Oceans and Law of the Sea Issues and the Special Envoy of the Minister for Foreign Affairs. In this capacity, she is serving as the President of the Intergovernmental Conference on an international legally binding instrument under the United Nations Convention on the Law of the Sea on the conservation and sustainable use of marine biological diversity of areas beyond national jurisdiction (BBNJ IGC). Rena is also a member of the Legal and Technical Commission of the International Seabed Authority (ISA).

REGISTERING A TRADEMARK ON THE GO!

Innovators and enterprises can now file their trademarks on-the-go. Trademark application is simple and fast, taking less than 10 mins to complete on the IPOS Go mobile app. The app integrates Artificial Intelligence (AI) technology to search for similar trademarks on the IPOS register, allowing applicants to pre-empt possible objections arising from similar existing trademarks before submission. This new feature is essential as more than forty percent of the world's trademarks filed today contain images.

As the world continues to see a surge in trademarks filings, the new AI capability provides business owners with greater clarity and certainty in their applications and will help them to better manage their brands.

IPOS Go signals IPOS' commitment to advance Singapore's Smart Nation agenda by offering digital innovations that serve to simplify and enhance Singaporeans' lives.

THE TEAM BEHIND IPOS GO:

As the Trademark Registry's Ops Tech team, we were given the exciting task of developing new strategic products and services to pre-empt our stakeholders' needs. Management has given us much latitude to dream and experiment while providing ample resources – all part of the innovative culture at IPOS.

IPOS implemented a series of changes to improve the user experience on both of our digital filing platforms. On IP2SG, the inclusion of an automatic translation tool has eliminated the need for applicants to provide a certified translation of foreign characters appearing in the trademark at the point of filing. The filing process has also been streamlined and legalese simplified for the layperson.

A predictive suggestion tool was also implemented on IP2SG and IPOS GO, to assist filers who may be overwhelmed by the different classifications of goods and/or services. The tool draws on information such as the applicant's industry and commonly-filed goods and/or services from the same industry. The enhancements make filing more intuitive for businesses seeking trademark protection, saving them time and money.

ALIBABA GRANTED EXPEDITED PATENT UNDER ACCELERATED INITIATIVE FOR ARTIFICIAL INTELLIGENCE



IPOS granted the first expedited patent under the Accelerated Initiative for Artificial Intelligence (AI2) to Alibaba Group. This was achieved in just three months - a world record for application-to-grant, which usually takes two to four years on average.

Mr Benjamin Bai, VP and Chief IP Counsel of Ant Financial (an affiliate of Alibaba Group) complimented Singapore's efforts in supporting enterprises in their go-to-market strategy, "We applaud the efficiency and speed of Singapore's IP office, and look forward to filing more patent applications in Singapore under this initiative."

BOOSTING THE FLOW OF INNOVATION COLLECTIVELY IN ASEAN



In a collective effort to boost the flow of innovation into the region, Singapore and eight other ASEAN IP offices have launched two new initiatives at IP Week@SG 2019.

The 9 participating ASEAN IP offices under the **ASPEC Acceleration for Industry 4.0 Infrastructure and Manufacturing (ASPEC AIM)** will prioritise patent applications in key emerging technologies such as FinTech, cybersecurity and robotics.

Under another new initiative, **the Patent Cooperation Treaty-ASPEC (PCT-ASPEC)** programme, patent applicants can now use their PCT reports from an ASEAN International Searching Authority and International Preliminary Examining Authority* to accelerate their patent applications in another ASEAN country.

To commemorate the 10th year anniversary of ASPEC, the revamped ASPEC brochure has also been launched.

DESIGNERS GET GREATER ASSURANCE IN INDUSTRIAL DESIGNS PROTECTION



The Locarno Agreement entered into force in Singapore on 19 March 2020, giving industrial designers greater assurance in protecting their designs. The Agreement is an international standardised classification system for industrial designs. It helps applicants identify the specific class their work belongs to when they file for industrial design protection, thus simplifying the user's search process across different databases. With this, Singapore is now signatory to 15 World Intellectual Property Organisation treaties, marking a continued commitment to harmonise Singapore's IP policies and legislations with international standards.

TEMASEK RICE RECEIVES BOOST FOR IP PORTFOLIO, READY FOR GLOBAL MARKET



Temasek Life Sciences Laboratory (TLL) received a boost to its IP portfolio with a Plant Varieties Protection (PVP) grant from IPOS. The grant recognises the unique properties of the Rice such as being highly aromatic, produces greater yield than its original variety, has the ability to withstand extreme weather conditions and is resistant to bacterial and fungal diseases.

Temasek Rice has existing patent and trade mark protection for the technology related to the cultivation of the rice as well as the "Temasek Rice" brand. With the latest grant under its belt, Temasek Rice will be able to enter and expand into 70 new markets overseas, including China, the US and Vietnam. This supports Singapore's vision of becoming a leading urban agriculture and aquaculture technology hub with a food production model that can be exported to the region.

SINGAPORE ELECTED AS VICE-CHAIR OF THE WORLD INTELLECTUAL PROPERTY ORGANISATION'S COMMITTEE ON PATENTS



Alfred Yip, Director, Patent Search & Examination, was appointed the Vice-Chair of the WIPO Standing Committee on the Law of Patents for a one-year term from June 2019. The Committee serves as a forum for countries to discuss global patent issues, including facilitating the development of international patent law to remain progressive, balanced and fair. As Vice-Chair, Alfred has been working alongside the Chair to guide and shape the **global discussion on patents**.

In cooperation with the Singaporean Ministry of Foreign Affairs' Singapore Cooperation Programme - SCP Friends, Singapore hosted a WIPO Regional Seminar on copyright for Asia-Pacific. The seminar was jointly organised by the WIPO Standing Committee on Copyright and Related Rights and the WIPO Singapore Office, and saw representatives and observers from over 35 countries gathered at the National Library for two days of discussions on copyright limitations and exceptions in the work of libraries, archives, museums and educational & research institutions. Event participants also gleaned insights on Singapore's 'goldilocks approach' to its Copyright Review, and the considerations undertaken to ensure that the rights of creators are balanced with the needs of users.

IPOS is also the co-chair of the multi-agency IP Working Group. IPOS also contributed to the National AI Strategy, and is committed to providing clear and accelerated patent protection for new AI innovations.

IPOS commemorated World IP Day 2019 through a series of programmes with our partners – World Intellectual Property Organisation (WIPO), International Association for the Protection of Intellectual Property (AIPPI), ASEAN IP Association (AIPA), and Singapore Press Holdings (SPH), for the IP community in Singapore.


There was a Rights Awareness Talk for the Art Community held on 23 Apr 2019. Marcus Liu, Senior Legal Associate at Amica Law LLC, shared about copyright and moral rights that are related to the art community in Singapore. Participants took away practical tips on how to better protect one's IP rights through due diligence checks and having contracts in place.

The 7th Community of Practice (COP) on IP Management held on 26 Apr 2019 drew over 100 participants from 27 public agencies. Titled "Powering R&D Decision-Makingwith IP Intelligence", the session highlighted how enterprises can utilise IP intelligence to uncover and utilise innovation opportunities to stay ahead of the competition. Speakers from public agencies also shared how R&D decisions that are driven by IP intelligence can benefit Singapore and Singaporeans.



On the same day, SPH commenced the public voting for the Singapore Creator Awards 2019, which spurred innovation and creative designs infused with Singapore culture and uncovered aspiring designers looking to break into the international design scene.

Concurrently, AIPPI organised the 4th AIPPI-ASEAN Regional Meeting, which featured IPOS' Director of the Registries of Patents, Designs and Plant Varieties, Alfred Yip, who spoke on the topic of FinTech and staying ahead of the innovation race. The AIPA invited IPOS' Chief Executive, Daren Tang, to moderate a high-level panel discussion at their AIPA Conference on 27 Apr 2019. The panel highlighted how ASEAN and the IP industry would evolve as a trading hub in the new world of e-commerce, digital free trade and trade alliances. The commemoration wrapped up with WIPO organising the Asia-Pacific Regional Seminar on 29-30 Apr 2019 at the National Library Board.



LINKING INNOVATION FLOWS WITH COMMUNITIES OF PRACTICE



The COP on IP Management brings together curious and innovative minds to learn best practices and impart skills to one another. This provides a continuous loop within the innovation ecosystem, that enriches each other's learning experience.

The 8th COP on IP Management was held in conjunction with IP Week @ SG 2019 on 27 Aug 2019. Titled "Tech Transfer Endgame: Unlocking the Secrets of the Trade", the session saw a lively sharing by international technology transfer experts from UK and Israel. These two countries are ranked top 10 in the Global Innovation Index 2019 and it was a privilege to hear their stories about commercialisation.

A ROUNDTABLE OF IP EXPERTS



The International Trademark Association (INTA) invited IPOS to a round of discussions by the IP Expert Group. Together with France's National Institute of Industrial Property and the Swiss Federal Institute of Intellectual Property, the Group explored the role IP offices would play in an innovation-led future economy. The Group also weighed in on how global trends such as Industry 4.0 and AI, would pose unique opportunities, but also challenges, to IP offices in the next 20 years. IPOS also shared about its transformation as an IP office and continuing international cooperation activities on ASEAN initiatives.

CELEBRATING FRAUNHOFER INSTITUTE'S 70th Anniversary





IPOS Chief Executive Daren Tang attended the 70th anniversary of Fraunhofer Institute, Europe's leading applied research institute. Held in Munich, the annual conference also had in attendance leaders in policymaking, research and industry, including Chancellor of Germany Dr Angela Merkel. Mr Tang was a Board member of Fraunhofer Singapore, where he worked with them to build Singapore's innovation ecosystem as well as strengthening the links between the innovation communities of Singapore and Germany.

During the visit, Mr Tang also met with the European Patent Office President Mr Antonio Campinos. IPOS and the EPO have enjoyed close cooperation over the years and will continue to explore ways in which our bilateral partnership can be expanded.

TECHNICAL Exchanges

IPOS and Brazil's National Institute of Industrial Property signed an MOU to support innovative enterprises and provide better market access. The MOU will also explore patent work sharing arrangements such as a pilot Patent Prosecution Highway.



IPOS signed an Implementation Workplan with the Intellectual Property Office of Vietnam to deepen bilateral cooperation in the areas of IP commercialisation and patent work-sharing.



To continue the sharing of search and examination results between Singapore and China's IP offices, both offices extended the PPH for two years until 31 August 2021. IP rights owners from both countries will continue to enjoy an expedited and a more straightforward application process when filing patents.

IPOS renewed its arrangement with the United States Patent and Trademark Office (USPTO) to act as an International Searching Authority and International Preliminary Examining Authority under the Patent Cooperation Treaty for international applications received by the USPTO. The signing took place on 4 December 2019 and the renewal will benefit applicants for an additional 8 years till 3 Dec 2027.



IPOS was officially appointed by the Uganda Registration Services Bureau (URSB) as a competent International Searching Authority and International Preliminary Examining Authority (ISA/IPEA) on 2 Dec 2019. As a competent ISA/IPEA, IPOS will be able to issue patent search and examination reports for international applications filed by nationals or residents of Uganda as a Receiving Office under the Patent Cooperation Treaty filed with the URSB.



IPOS deepened cooperation with Laos' Department of IP. The cooperation bridges the innovation ecosystems of both countries to support the transformation of IP and IA into products and services for the region. Specifically, Laos will be able to tap on Singapore's patent search and examination expertise to grant quality patents in Laos. Singapore-granted patents can be re-registered in Laos, allowing innovative enterprises to save valuable time and money when accessing markets.



IPOS welcomed H.E. Cham Prasidh and his team to the IPOS office earlier in Jan 2020. IPOS and the Cambodia Ministry of Industry and Handicraft renewed cooperation with an MOU for another 5 years. This will allow Singapore patents to continue to be re-registered in Cambodia, and for MIH to continue to engage IPOS' search and examination services.

The MOU between IPOS and the UK Intellectual Property Office will support the SG-UK Partnership for the Future framework. Under this agreement, both offices will explore cooperation in the areas of IP protection, commercialisation and utilisation.



The Agreement with the Qatar Free Zone Authority will support bilateral economic engagements between both countries. This will be achieved through a community sharing of best practices and knowledge on the management of IA and IP, as well as developing closer linkages between the innovation ecosystems of both countries.

IPOS signed an MOU with Ecuador's National Service of Intellectual Rights (SENADI) on 17 Feb 2020. Under this agreement, both IP offices will cooperate further in the areas of IP management to promote economic and innovation development, in recognition of the importance of intellectual property and intangible assets.

IPOS International expanded its global network with bilateral MOUs signed with Japan, China and Russia. Innovative enterprises from these countries can look forward to tapping IPOS International's suite of services, with a view to accessing new markets, using Singapore as an IP Hub.

IPOS International also formalised IP collaboration with Suzhou Industrial Park (SIP) and China-Singapore Guangzhou Knowledge City (CSGKC) in 2019. The latter commits to developing the China-Singapore International IP Innovation Service Center in CSGKC. The Centre will support Chinese enterprises looking to expand into ASEAN through Singapore.

Likewise, innovative enterprises will be able to use Singapore and Kazakhstan as gateways to access high-growth markets in ASEAN and the Central Asia region, as part of a tripartite Memorandum of Understanding with the Astana Financial Services Authority and the Ministry of Justice of the Republic of Kazakhstan.

The value of the global economy is increasingly held in IA. Yet these assets continue to be underinsured, despite the potential of higher business loss in the face of adverse IP proceedings. IP III - underwritten by Antares Underwriting Asia, on behalf of Lloyd's of London - will allow enterprises to get insurance coverage for legal expenses that may be incurred in IP infringement proceedings. This supports enterprises to mitigate against business risks that may emerge as they enter global markets for growth.

IP Week @ SG 2019 saw close to 4,000 attendees from over 45 countries come together at Marina Bay Sands Singapore. The world's premier IP event brought together the world's IP thought leaders, legal experts and innovative enterprises from over 45 countries for two-days of scintillating discussions on commercialisation and winning strategies for enterprise growth. With close to two-thirds of the delegates from the business sector, the event underscores the increasing importance of IP and innovation to sustain business growth.

In his opening remarks, Mr Chan Chun Sing, Minister for Trade and Industry, called on the need to build multi-disciplinary teams that draw on business, technology and legal capabilities to drive global growth through IP and IA. Minister Chan also announced the **launch of IPOS International**, which will serve as a one-stop IP shop for enterprises seeking IP strategy and management, patent search and analysis, and training. A world's first national-level framework to develop and train IP talent was also unveiled. The **new Skills Framework for IP** will support the demand for skilled IP manpower in the local innovation ecosystem, and boosts Singapore's position as an IP hub.



At the opening ceremony, Minister Chan also gave out the prestigious WIPO-IPOS Intellectual Property Awards 2019 to three innovative Singapore companies, Razer (Asia-Pacific) Pte Ltd, Biolidics Ltd and Durapower. The Awards celebrate the achievements of innovative enterprises that demonstrate strategic management and commercialisation of IP and IA that they create and own. Amongst the companies, Razer (Asia-Pacific) emerged as the grand winner of WIPO-IPOS IP Awards 2019 edition, claiming three of five awards.



In the spirit of 2019's event theme, IPOS granted a patent to Alibaba Group in a world record of three months, through the **Accelerated Initiative for Artificial Intelligence programme**. IPOS also announced the new **ASPEC-AIM initiative** that will expedite patent applications in key emerging technologies.

The new initiative taps into the region's estimated potential market valued between US\$216 billion to US\$627 billion and will run for two years with eight other participating ASEAN IP offices.



The event also saw the launch of the Institute of Singapore Trade Mark Agents (ISTMA) and the **Future Leaders in INnovation Transformation (FLINT)**. The latter initiative by IPOS seeks to nurture the next generation of IP-savvy youths. The inaugural FLINT session was attended by more than 100 entrepreneurial students and representatives from the various tertiary institutions.

WIPO also organised the *Heads of Intellectual Property Office Conference*, graced by heads of over 20 IP offices and associations. Representatives from the African Regional IP Organisation, Turkey, the UK, Alibaba, Ant Financial Services, Boston Consulting Group, Facebook, Huawei, IBM Corporation, Nokia and Rolls-Royce immersed themselves in in-depth discussions on innovation and IP. Several agreements were inked during the conference, furthering Singapore's **networks with the global innovation communities** as partnerships explore cooperation in IP protection, commercialisation, training and the sharing of best practices. These new initiatives and partnerships will allow Singapore to bring value to global innovation flows and drive economic growth for the nation and region.







Tech giants in the 5G space – Huawei and Nokia - also took the stage at an exclusive closed-door CEO luncheon. Supported by the Association of Small and Medium Enterprises, the Singapore Manufacturing Federation and Enterprise Singapore, CEOs in the audience gleaned insights on navigating IP issues in the complex global environment and the importance of collaboration in IA and IP in the midst of a fragmented world. The luncheon was attended by Ambassador Tan Hung Seng (Singapore's Permanent Representative, World Trade Organisation), H.E. Christopher Onyaga Aparr (Permanent Representative of Uganda to the United Nations in Geneva), and H.E. Chi Dung Doung (Mission of Vietnam to the United Nations Office, WTO and other International Organisations in Geneva).

THE WRITE CONNECTION THE RIGHT PLANS FOR THE WRITE CONNECTION

The Write Connection (TWC) is a Singapore-based English education centre that has nine outlets across the island. The COVID-19 global pandemic accelerated the adoption of digital tools to ensure that businesses would be able to continue running with little to no disruption. Ms Katherine Barg, Founder and CEO, reported that they have set up an online business (TWC@ Home) during the pandemic and now have students joining them from seven countries, ranging from neighbouring countries like Indonesia to countries like USA, Japan and New Zealand.

"We have implemented the recommendations by IPOS International to facilitate the growth of our online and offline business," says Ms Barg. 
IP MANAGEMENT (GOVERNMENT) [IPMG]

IPMG supports public agencies in the management of publiclyfunded IP. Some of the assistance rendered to fellow agencies include developing IP Policies in line with the National IP Protocol, providing insights through patent analytics to determine or validate potential research areas, as well as providing training to public officers in areas of IP management. Since 2017, the team has worked on close to 50 projects for public agencies.

CIVIL SERVICE COLLEGE NAVIGATING IP RIGHTS IN THE DIGITAL SPACE TO DEVELOP LEARN CONTENT



The "LEARN" app was developed by the Civil Service College (CSC) as a one-stop digital learning platform for public officers in Singapore to upskill themselves. The content would comprise existing content (CSC's proprietary content and third-party content) and new content to be developed either internally and/or by third parties. However, CSC faced the challenge of navigating IP rights in the digital space – clearing rights to digitise existing content, and securing the necessary rights to host new content.

Our IP Strategists developed a set of operational processes and checklists to enable the CSC officers to manage the many IP issues in building a repository of digital content for the LEARN app. This included how to:



Review and/or modify agreements to determine if existing content could be digitised and hosted on the LEARN app;



Review and develop agreement templates to ensure that new content could be used for the LEARN app; and



Enable CSC officers to negotiate for new content agreements with thirdparty content providers.

JURONG TOWN CORPORATION Developing an IP management policy to enable strategic r&d outcomes

Jurong Town Corporation (JTC) provides infrastructure solutions to meet the needs for current and future industries. The collaborative innovation process with industry results in the generation of new technologies and other IPs.

JTC sought the assistance of IPOS to develop a policy for IP management for IPs, aligned with the principles of the National IP Protocol. Through surveys, interviews and focus group discussions, our IP Strategists developed an IP Policy with clear guidance, tools and processes that would assist JTC officers to:

Secure the necessary rights to use the IP for its operations whilst facilitating commercialisation of the IP by the industry for value capture for Singapore;

Derive an equitable sharing of economic benefits arising from the commercialisation of IP; and

Avoid unnecessary risk from the mismanagement and mishandling of IP.

SINGAPORE AS THE DESTINATION FOR IP DISPUTE RESOLUTION

Fifty-two countries, including the United States and China, have signed a new international treaty on mediation named after Singapore as of March 2020. Prime Minister Lee Hsien Loong has called the Singapore Convention on Mediation **"a powerful statement in support of multilateralism"**, that will help to advance trade, commerce and investment. With the Convention, innovation-driven enterprises will be assured that mediated settlement agreements can be enforced in cross-border disputes.

Also taking place in August 2019 was the passing of the IP (Dispute Resolution) Act. With effect from November 2019, the Act clarifies that IP disputes can be arbitrated in Singapore, further enhancing Singapore's reputation as an IP Dispute Resolution Hub.

The Singapore government also reaffirmed its commitment to work with the World Intellectual Property Organisation Arbitration and Mediation Center (WIPO Center) on serving the Asia-Pacific region in the field of IP alternative dispute resolution. In a joint initiative between WIPO Center and IPOS, the creative community will now have access to reduced rates for mediation to resolve any copyright disputes in Singapore at the WIPO Center, strengthening Singapore's position as the region's alternative dispute resolution hub.

The WIPO Center's only office outside of Geneva was established in Singapore in 2010.

FIRST INTERNATIONAL SUCCESS CASE UNDER ENHANCED MEDIATION PROMOTION SCHEME, SPANS MULTIPLE JURISDICTIONS



Many of my clients have come away from mediation rather satisfied. They may have made some compromises in coming to an agreement with the other side but they are relieved that the dispute was quickly resolved in a cost effective way. The Scheme saw its first successful mediation that involved a multi-jurisdictional IP dispute between American and Thai parties. The dispute was resolved under the WIPO Center in Singapore where Representatives from both parties met and agreed to extend mediation of foreign IP rights in Vietnam, Indonesia, Philippines, Malaysia and Thailand.

The Scheme is the first of its kind that directly reimburses parties' mediation-related costs such as administration and mediator's fees, as well as parties' mediation-related lawyer fees and disbursements.



HIGHLIGHTS FROM IPOS' HEARINGS

Over the past year, many cases with international elements have benefitted from the wide and neutral perspective provided by IPOS' hearing officers and panel of IP Adjudicators that span across academia, public and private sectors. This underscores Singapore's robust IP regime and anchors Singapore's aim to be a dispute resolution hub in IP.

CLASH OF THE CLUBS

The Harvard Club of Singapore opposed the registration of Application Marks 'Harvard Club of Singapore' and 'Harvard University Club of Singapore' by Harvard University. The former relied on grounds of bad faith and passing off. The Hearing Officer disagreed and concluded that the applicant owned the goodwill connected with "Harvard", and was also free to file its trademarks any time. The decision was upheld on appeal to the High Court.

ALL THAT GLITTERS IS NOT GOLD

This sweet treat applied to protect its three-dimensional shape as a trademark but ultimately failed to do so. The mark was in fact observed to be a composite mark comprising shape, colour and packaging, as well as an oval white sticker with no words (on which the word mark "FERRERO ROCHER" is printed when the Application Mark is used in practice). The IP Adjudicator found that the Application Mark is devoid of any distinctive character, and has not acquired any distinctive character as a result of use.

COOLING THE HEAT

Multi Access Limited argued that the trademark applied by Guangzhou Pharmaceutical, 'WONGLO', is confusingly similar to its 'WONG LO KAT' mark. However, the Hearing Officer disagreed, on grounds that the marks are more dissimilar than similar; with 'WONG LO KAT' sounding like a full name, compared to 'WONGLO' which may be perceived as an invented word. The latter could therefore be registered. The decision was upheld on appeal to the High Court.

This marks the first time a Singaporean will lead a UN agency, and WIPO's Director General hails from Asia. WIPO is a specialised United Nations (UN) agency based in Geneva, Switzerland with 193 member states. We recap the journey that Singapore has made as we celebrate this historic milestone.



In Oct 2019, Singapore attended the 59th WIPO General Assembly held in Geneva. In his national statement, IPOS CE Mr Daren Tang affirmed the pivotal role IP offices play in their ability to encourage innovation. He shared how IPOS expanded its remit from an IP registry and regulator to an innovation agency, embraced digitalisation to transform the customer experience and partnered both public and private sectors to enable enterprise scale-up.

The Republic also reaffirmed her commitment to multilateralism, and being a trusted and neutral partner to innovation and IP stakeholders. Ambassadors and heads of delegations joined the Singapore Luncheon - jointly hosted by the Permanent Mission to Geneva - to discuss how IP offices could broaden their mission beyond regulatory work and harness IP to help drive enterprise and economic growth and in turn, deliver positive social impact.

First conceived by WIPO in 2014, a "Guidelines to Using Evidence from Research to Support Policymaking" report was also launched. Singapore was the principal Asian IP Office contributing to the report, alongside chief economists and IP heads from Australia, Canada, Europe Patent Office, European Union, Switzerland, UK, and the USA.



SINGAPORE NOMINATES CANDIDATE FOR THE WIPO DIRECTOR GENERAL ELECTIONS

In Nov 2019, IPOS CE Mr Daren Tang was put up as Singapore's candidate for the elections to the post of Director General (DG) of WIPO. Ambassador-at-Large Professor Tommy Koh led the round of formal introductions of Mr Tang to the Diplomatic Corps.

In his Facebook post, Prof Koh noted Mr Tang's skills and commendable achievements as a key member of the Singapore delegation which negotiated the Trans-Pacific Partnership and Regional Comprehensive Economic Partnership. "As a Singaporean, he would be an excellent honest broker and bridgebuilder between the north and the south and between the east and the west."



This afternoon I had the great pleasure of introducing to the Diplomatic Corps, Singapore's candidate for the post of Director General of the World Intellectual Property Organisation or WIPO. Our candidate is Daren Tang, the Chief Executive of the Intellectual Organisation of Singapore or IPOS. Daren was a member of the team which negotiated the free trade agreement with the United States. He was a key member of the singapore delegations which negotiated the TPP and RCEP. During his tenure at IPOS he has transformed it into an innovation agency. Singapore is recognised as having the best IP regime in Asia and one of the best in the world. He is currently the chair of the standing committee on copyright at WIPO. As a singaporean he would be an excellent honest broker and bridge builder between the north and the south and between the east and the west.

A FRUITFUL EXCHANGE WITH THE AFRICAN REGIONAL IP ORGANISATION



IPOS took part in a meaningful exchange with the African Regional IP Organisation (ARIPO). IPOS CE Mr Tang shared Singapore's experience in transforming our IP Office to support innovators and enterprises. The visit also coincided with a sharing session with the Ministerial Council. The discussion centred on how IP and innovation can create meaningful jobs and raise the overall socioeconomic environment for countries.

As Africa becomes a buzzing hub for innovation with African start-up activity being 13% higher than the global average, these conversations are crucial in jointly developing an inclusive global IP ecosystem that benefits all.



IPOS CE Mr Tang shared IPOS' journey of transformation with the Organisation Africaine de la Propriété Intellectuelle (OAPI) in N'Djamena, Chad. During the visit, he emphasised **deepening cooperation and collaboration between Africa and Asia** in the field of IP, and in bringing both regions closer through more exchange and collaboration programmes. The links built between both ecosystems will help to foster and build a more vibrant global landscape.



WIPO COORDINATION COMMITTEE: SINGAPOREAN AS DIRECTOR GENERAL NOMINEE



IPOS CE Mr Tang received the nomination by WIPO's Coordination Committee to be its next Director General. Mr Tang was selected from a slate of nominees which originally comprised 10 candidates from Argentina, China, Colombia, Estonia, Ghana, Japan, Kazakhstan, Nigeria, Peru, and Singapore.

Voting took place over two rounds. In the final round of voting between Singapore and China, Mr Tang garnered 55 out of the 83 votes. This is the first time a Singapore national has won nomination to the leadership position of any UN agency.

It was a multi-agency effort to canvass support for Singapore's candidate in the lead up to nominations before WIPO's 83-member Coordination Committee. Mr Tang expressed deep appreciation for the government agencies involved in this Whole-of-Government effort, "This was a team effort across many government agencies, including IPOS, the Ministry of Foreign Affairs, the Ministry of Law, Missions around the world and special envoys, all of whom worked hard over many months to lobby for support, and always in a way that flew our flag as Singapore."

In his congratulatory note to Mr Tang, Dr Stanley Lai, SC, Chairman of IPOS, said, "On behalf of the IPOS Board of Directors, I am pleased to extend felicitations to IPOS CE Daren Tang and all Ministries and agencies that contributed so effectively to the whole-of-government effort that made this historic milestone possible.

Daren's election by WIPO member states demonstrates the significant esteem that countries hold for Singapore and our commitment to effective protection and enforcement of intellectual property rights, in support of innovation, research and enterprise. It is a veritable achievement of great consequence, for which Team Singapore should be most proud." #TeamSingapore!



WIPO'S 5th director general Officially appointed during wipo ga

Mr Tang was officially appointed as the next Director General of WIPO. Mr Tang's six-year term will begin on 1 Oct 2020, and he will relinquish his position as Chief Executive of IPOS. This marks the first time a Singaporean will helm a UN agency.

In response to travel restrictions due to the COVID-19 situation, member states confirmed the nomination via silent procedure. In a specially-recorded acceptance video, Mr Tang thanked member states and paid tribute to outgoing DG Dr Francis Gurry.

He also called on members to continue building consensus and cooperation in the next chapter of WIPO, and outlined **his plans for a more inclusive**, **balanced and forward-looking IP ecosystem** that will benefit all nations:





More support to developing countries and least developed countries;



Working with IP offices to support stakeholders including artists, creators, start-ups, and SMEs;



Optimising WIPO's international registration systems;



Re-energising WIPO's normative agenda;



Broadening the perspective of IP beyond its legal and technical aspects to its role in connecting innovators and artists to markets and communities;



Partnering various international organisations on solutions to global challenges such as sustainable development, climate change, public health, access to information and knowledge; and



Building a culture of strong governance, diversity, mutual respect, passion, effectiveness, and financial prudence within the organisation.
