To cooperate with foreign copyright protecting organizations in order to protect the interests of the authors who have transferred their copyright; 5. To protect the interests of the transferor-authors before the competent government authorities, courts, arbitrators, and other organizations and individuals; 6. To conduct other activities in conformity with laws and the Center's regulations.
